

REGULAR MEETING AND PUBLIC HEARING OF THE GOVERNING BODY OF THE CITY OF BLANCO

Meeting Minutes April 9, 2024

A regular meeting and public hearing of the City Council, City of Blanco, Texas was held on April 9, 2024, at 6:00 pm at the Byars Building, 308 Pecan Street, Blanco, Texas.

The meeting was called to order at 6:00 pm by Mayor Arnold, followed by roll call announcing a quorum was present. The Invocation and the Pledge of Allegiance was led by David Mayer. Council members present: Mayor Arnold, Mayor Pro-Tem Thrailkill and Council Members Smith, Swinson, and Moses.

City staff present: Warren Escovy, City Administrator, Laurie Cassidy, City Secretary, and Lt. Jerry Thornhill.

Mayor Arnold made the following announcements:

- Founders Day was a success!
- Eclipse went smoothly!
- The burn ban is currently off.
- Water restrictions are currently at Stage 2, please be mindful of your water usage.

Public Comments:

- Jay Palmer, Blanco County resident, spoke regarding negative social media/Facebook posting and also about the US 281 Relief Route and his concerns with the TxDOT Bypass Routes 3, 4, and 5.
- Kristen Jones shared a story and spoke out against the TxDOT US 281 Relief Route.
- Retta Martin, City of Blanco resident, spoke regarding KBB Trash Off, this Saturday, 8 am to noon (truck brigade). She also spoke about the Comprehensive Master Plan (CMP), the citizens plan and the Historic District. Mayor Arnold pointed out no plan has been worked on; the council is only discussing restructuring of committee(s).
- Kenneth Welch, Blanco County resident spoke regarding New Business item 9, the TxDOT US 281 relief route. He also spoke on Old Business item 1, CMP should be discussed in open session, and he said Executive Session item 5 is puzzling.
- Courtney Trent, Blanco County resident, spoke out against the TxDOT US 281 Relief Route. She is in support of the NO build option.
- Janie Jones, Blanco County resident, spoke out against the TxDOT US 281 Relief Route.
- Gail McClellan, City of Blanco resident, thanked the City Council for being such faithful supporters and friends to Keith McClellan.
- Waymond Lightfoot, City of Blanco resident at 1334 Sunset Ridge spoke out against the TxDOT US 281 Relief Route.

- Randall Pawlik, not a Blanco resident, but has family in Blanco and spoke out against Route 3 and 4 of the TxDOT US 281 Relief Route, his choice is the NO Build option.
- Stephanie Wright, City of Blanco resident spoke out as a resident and NOT on behalf of the Blanco County New paper. She spoke regarding observations made to increased traffic on US 281 as well as arterial streets after the eclipse. She also said she looks forward to the discussion on New Business item 5, concept plan for street repair and maintenance fee.
- Brian Faris, not a Blanco resident, but a property owner near routes 4 and 5, spoke in favor of the NO build option, regarding the TxDOT US 281 Relief Route study.

Public Hearing: Opened at 6:32 pm with no comments and closed at 6:32 pm.

• Final Public Hearing for the TxCDBG 7220040 Lift Station Grant (Janell Foster, Langford Community Services).

Mayor Arnold read the National Preservation Month 2024 Proclamation.

Staff Presentations:

- City Hall, Warren Escovy, City Administrator, shared the following: -Eclipse, was not what
 we expected, lower turnout, the police department and Lt. Thornhill did a great job managing
 the traffic; -Blanco Founders Day #1 was a huge success; -Election is coming up May 4, 2024,
 -Meter audit update to be discussed later tonight, and -the Lift Station has been moved out of
 the floodplain.
- Police Department, Lt. Thornhill presented the March Monthly Report. He also spoke about the Speed Trailer positioned near Peterson's, 6 am and midnight, 45 thousand vehicles passed through, 4/8/24, no accidents, great coordination. Appreciates the hard work of the Blanco Police Department.

Consent Agenda: *The following items may be acted upon in one motion*. No separate discussion or action is necessary unless requested by the Mayor or a Council Member, in which those items will be pulled for separate consideration.

- 1. Approval of Minutes from the March 4, 2024, Special Meeting.
- 2. Approval of Minutes from the March 12, 2024, Regular Meeting and Public Hearing.
- 3. Approval of Minutes from the March 20, 2024, Special Meeting.

A motion was made by Mayor Pro-Tem Thrailkill to approve the consent agenda items one and two as presented, seconded by Council Member Smith, all in favor, motion carried unanimously. A motion was made by Council Member Smith to approve consent agenda item 3, seconded by Council Member Swinson, motion carried 3-0, with Mayor Pro-Tem Thrailkill abstaining from the vote.

New Business: Consider, discuss, and take appropriate action on the following:

1. Consideration, Discussion and Take Possible Action on Approval of Resolution 2024-R-008 Performance Guarantee Contract with Performance Services, Inc. (Warren Escovy, City Administrator). Warren asked to table, to be restructured and brought back in May 2024, no action taken.

- 2. Consideration, Discussion and Take Possible Action on Approval of Resolution 2024-R-009 Award of Professional Services Contract to Langford Community Services, Resilient Communities Program of the TX GLO CDBG-MIT Program (Jerri Conrado, Langford Community Services). A motion was made by Council Member Smith to approve Resolution 2024-R-009 Award of Professional Services Contract to Langford Community Services, Resilient Communities Program of the TX GLO CDBG-MIT Program, seconded by Council Member Moses, all in favor, motion carried unanimously.
- 3. Consideration, Discussion and Take Possible Action on Approval of Resolution 2024-R-010 and Amendment to the current construction contract with M&C Fonseca for the TxCDBG Grant #7220040 and CDV21-0456 City of Blanco's Lift Station improvement projects to allow the 7220040 CDBG grant to be closed with TDA and the CDV21-0456 Generator grant to continue through completion. (Janell Foster, Langford Community Services). Ms. Foster explained the original Lift Station grant needs to be closed out. The part for the generator (second grant) is in and ready to be installed. A motion was made by Council Member Smith to approve Resolution 2024-R-010 an amendment to the current construction contract with M&C Fonseca for the TxCDBG Grant #7220040 and CDV21-0456 City of Blanco's Lift Station improvement projects to allow the 7220040 CDBG grant to be closed with TDA and the CDV21-0456 Generator grant to continue through completion, seconded by Mayor Pro-Tem Thrailkill, all in favor, motion carried unanimously
- 4. Consideration, Discussion and Take Possible Action on Approval of Possible Voluntary Annexation of Properties Around the City Wastewater Treatment Plant and any Properties along the future US Highway 281 Relief Route (Mayor Arnold). Council discussed. Council Member Smith asked to table this item, no action taken.
- 5. Consideration, Discussion, and Take Possible Action on Approval of Concept Plan for Street Repair and Maintenance Fee. Warren Escovy, City Administrator spoke regarding new street repair and maintenance program to be supported by a fee program and purchased with certificates of obligation money. The program would consist of one additional employee, supervised by Inframark and purchase of equipment, \$100,000 pothole filling machine (funded by certificates of obligation). A two person crew would fill potholes, trim ROW, and complete minor maintenance. Council discussed. The Mayor would like to wait until May after the new Council has been sworn in and the residents have had the opportunity to provide feedback. Council Member Smith asked to table this item, no action taken.
- 6. Consideration, Discussion, and Take Possible Action on Approval of Use of HOT Funds to Employ Part Time Code Enforcement Officer to Enforce 15 Dark Sky Violations. Warren Escovy discussed the process, speak to the violator first, make them aware, due to limited staff, would need to hire part time person, cost is approximately \$100 per violation and staff's recommended is that council authorize city administration to use HOT funds to hire code enforcement officer to work on dark sky violations. Council discussed. Table item to next month, Mayor Arnold and Council Member Moses to split up list and call each violator to inform/educate them. Council Member Swinson mentioned there are also about ten short-term rentals in violation. Warren said staff will work on these as well. No action taken.
- 7. Consideration, Discussion, and Take Possible Action on Acceptance of Utilities at Los Altos Phase 1. Warren Escovy, City Administrator discussed and said staff recommendation is to allow city engineering and administrator to accept water and sewer lines for Los Altos Subdivision Phase I. A motion was made by Council Member Swinson to accept the utilities at Los Altos Phase 1, seconded by Council Member Smith, all in favor, motion carried unanimously.

- 8. Consideration, Discussion, and Take Possible Action to provide traffic calming on 12th Street from Mesquite to Greenlawn. Warren Escovy, City Administrator spoke asking Council for staff guidance and input from Acting Police Chief Thornhill, who recommended installing two stop signs. A motion was made by Council Member Smith to approve recommendation of two stop signs, one at each end of 12th Street at a cost not to exceed \$1,000, seconded by Mayor Pro-Tem Thrailkill, all in favor motion carried unanimously.
- 9. Consideration, Discussion and Take Possible Action relating to TXDOT Study of Possible Relief Route on Hwy 281 (Mayor Arnold). Council discussed and shared the timeline of events. Transportation Committee Chair, Kenneth Welch recommended doing nothing at this time and he will give monthly updates on his communications with TxDOT. A motion was made by Council Member Smith to NOT rescind the letter of January 10, revisit item, and listen to Kenneth Welch, Transportation Committee Chair to not do anything right now, seconded by Mayor Pro-Tem Thrailkill, motion carried 3-1 with Council Member Moses opposed.

OLD BUSINESS: Consider, discuss, and take appropriate action on the following:

- Consideration, Discussion and Take Possible Action on Authority and Structure of
 Comprehensive Master Plan Committee. Council discussed concerns regarding the structure of
 committee, ongoing fundraising of large amount of funds and current bookkeeping practices.
 Suggestion made to move the Streetscape Committee under the CMP Committee to allow the city
 to oversee the finances and to see the goals of the Streetscape plans to completion. Council
 suggested staff receive input from the Historic Preservation Commission and the Streetscape
 Committee. No action taken.
- 2. Consideration, Discussion, and Take Possible Action on Approval of Extension of City Services or Disannexation of 4.99 Acre Property at 1917 N. US Hwy 281 located in the H. Eggleston Survey No. 24, Abstract No. 0001, Blanco County, Texas. Warren Escovy shared with council the property owner has petitioned for deannexation. Council needs to make a decision on how to move forward. Tim Tuggey and the council discussed. **No action taken**.

ORDINANCE 2024-O-004

AN ORDINANCE REPEALING SELECTED PROVISIONS OF THE UNIFIED DEVELOPMENT CODE RELATING TO LOOSE LIVESTOCK AND MAXIMUM HEIGHT OF WEEDS AND OTHER VEGETATION

WHEREAS, City Council has previously expressed its intention, by resolution, to repeal certain provisions of the City Unified Development Code (UDC) relating to loose livestock and maximum height of weeds and other vegetation;

WHEREAS, it is in the public interest and serves the public welfare to repeal the related provisions of the UDC, by ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLANCO:

SECTION 1. FINDINGS OF FACT

That the facts and matters set forth in the preamble of this Ordinance are true and correct.

SECTION 2. AMENDMENT OF UNIFIED DEVELOPMENT CODE (UDC)

The City's UDC is hereby amended by repeal of Section 3.02.003 (Loose Livestock) and Section 7.03.008 (Maximum Height of Weeds and other Vegetation).

SECTION 3. EFFECTIVE DATE; IMPLEMENTATION AND ENFORCEMENT DATE

This ordinance is effective on the date of publication of notice of adoption on the City's website and the local newspaper of general circulation, each of which shall be made not later than ten (10) days after adoption.

SECTION 4. SEVERABILITY & REPEALER

If any provision of this ordinance shall be adjudged invalid or unconstitutional, the same shall not affect the validity of this ordinance as a whole or in part, except the part held or adjudged invalid or unconstitutional. Upon adoption, the provisions of this ordinance repeal any inconsistent existing provisions of other City ordinances.

Issues for Consideration by Blanco City Council:

- 1. Implementation of a \$5,000 Retention/Recruiting Incentive Program: In alignment with our recruitment and retention objectives, a structured \$5,000 incentive program has been formulated.
 - a. For newly hired personnel, this incentive will be distributed in two phases. The initial disbursement will occur upon successful completion of the Field Training Officer (FTO) Program, with the remaining portion allocated upon the successful culmination of their one-year probationary period.
 - Regarding the retention incentive, incumbent officers have already received \$3,200, with the remaining \$1,800 scheduled for disbursement before the conclusion of the 2024 fiscal year. These funds are derived from previously unutilized payroll allocations.
- 2. Expedited testing for Corporal Openings: By immediately implementing testing procedures for corporal positions, we enhance career progression opportunities for our officers, thus incentivizing professional growth and development. This proactive measure underscores our dedication to fostering a meritocratic environment and providing avenues for advancement based on competency and performance rather than tenure or seniority alone.
- 3. Bi-lingual Incentive Program: An incentive of \$25.00 per month, equating to \$300.00 annually, is proposed to acknowledge the value of linguistic diversity within our workforce. This initiative not only promotes language proficiency but also fosters inclusivity and bolsters community engagement.

RESOLUTION 2024-R-012

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLANCO, TEXAS, AUTHORIZING THE CITY TO ENTER INTO A PERFORMANCE GUARANTEE CONTRACT WITH PERFORMANCE SERVICES, INC. RELATING TO THE ACQUISITION AND INSTALLATION OF PERSONAL PROPERTY, AND ENTER INTO A PUBLIC PROPERTY FINANCE ACT LEASE PURCHASE AGREEMENT WITH FIRST SECURITY FINANCE, INC. TO FINANCE THE COSTS THEREOF; AND APPROVING CERTAIN OTHER DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH.

WHEREAS, the City of Blanco, Texas (the "City") is a political subdivision duly organized under the constitution and laws of the State of Texas; and

WHEREAS, it is hereby determined that a true and real need exists for the acquisition and installation of certain personal property, consisting of approximately 1,231 water meters and related advanced metering infrastructure improvements at various locations throughout the City and other areas served by the City's water department, and replacement of the Palomino Water Line (collectively, the "Project"), as identified in the herein-after defined Performance Guarantee Contract; and

WHEREAS, the City is authorized under the Constitution and laws of the State of Texas (the "State") to enter into a public property finance act lease purchase agreement to finance the acquisition and installation of the Project; and

WHEREAS, in order to accomplish the foregoing, it is necessary and desirable for the City to enter into the following documents (the "Transaction Documents"):

- 1. Performance Guarantee Contract (the "Contract") between the City and Performance Services, Inc. relating to the acquisition and installation of the Project;
- 2. Public Property Finance Act Lease Purchase Agreement (the "Agreement") with First Security Finance, Inc., as lessor (the "Lessor"), in a principal amount (including capitalization of interest and closing costs) not to exceed \$1,900,000, a maturity date of no later than December 31, 2044, and an interest rate of 5.49% per annum, for the purposes described therein, including to provide financing for the Project;
- 3. Escrow Agreement with the Lessor and the escrow agent named therein for the purpose of establishing an acquisition fund into which the Lessor will deposit an amount equal to the aggregate principal components of rental payments under the Agreement; and
- 4. Federal Tax Agreement (the "Tax Agreement"), setting forth certain representations, facts, expectations, terms and conditions relating to the use and investment of the proceeds of the Agreement in order to establish and maintain the exclusion of the interest portion of rental payments under the Agreement from gross income for federal income tax purposes and in order to provide guidance for complying with the arbitrage rebate provisions of the Internal Revenue Code upon the terms and conditions as set forth in the Tax Agreement.

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF BLANCO, TEXAS, AS FOLLOWS:

Section 1. The Transaction Documents are hereby approved in substantially the forms submitted to and reviewed by the City Council of the City on the date hereof, with such changes therein as are deemed necessary by the City's attorney and approved by the Mayor or the City Administrator of the City (each, an "Authorized City Officer"), said officer's execution thereof to be conclusive evidence of the approval thereof. The Authorized City Officer is hereby authorized and directed to execute and deliver the Transaction Documents on behalf of and as the act and deed of the City. The City Secretary is hereby authorized to affix the City's seal thereto and attest such as may be necessary.

Section 2. During the term of the Agreement, as security for the amount necessary to pay the rental payments and all other amounts payable thereunder, the City has agreed to pledge its ad valorem taxes. The City will use its revenues generated from the operation and maintenance tax levy under Article XI, Section 4, Texas Constitution (the "Limited Tax") revenues and other revenues and funds lawfully available to pay the rental payments and all other amounts payable under the Agreement and shall deposit all such funds in accordance the Agreement. Pursuant to the Agreement, the City shall levy and agrees to assess and collect, a continuing direct annual Limited Tax on all taxable property within the boundaries of the City, within the limitations prescribed by law, at a rate from year to year sufficient, together with such other revenues and funds lawfully available to the City for the payment of rental payments and all other amounts payable under the Agreement, to provide funds each year to pay the rental payments and all other amounts payable under the Agreement, full allowance being made for delinquencies and costs of collection. The Limited Tax and such revenues and funds in an amount sufficient to pay rental payments and all other amounts payable under the Agreement shall be pledged to the Lessor for such purpose as the same shall become due and payable under the Agreement.

Section 3. The City hereby designates the Agreement as a "qualified tax-exempt obligation" for purposes of Section 265(b) of the Internal Revenue Code. In furtherance of such designation, the City represents, covenants and warrants the following: (a) during the calendar year 2024, the City (including any subordinate entities) has not designated nor will it designate obligations, which when aggregated with the Agreement, will result in more than \$10,000,000 of "qualified tax-exempt obligations" being issued; (b) the City reasonably anticipates that the amount of tax-exempt obligations issued during the calendar year 2024 by the City (including any subordinate entities) will not exceed \$10,000,000; and (c) the City will take such action or refrain from such action as is necessary in order that the Agreement will not be considered "private activity bonds" within the meaning of section 141 of the Code.

Section 4. The City shall, and the officials and agents of the City are hereby authorized and directed to, take such action, expend such funds and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this resolution and to carry out, comply with and perform the duties of the City with respect to the Transaction Documents and the acquisition and installation of the Project.

Section 5. The City has made certain capital expenditures in connection with the acquisition and installation of the Project prior to the date hereof, and the City expects to make additional capital expenditures in connection with the acquisition and installation thereof in the future. The City intends to reimburse itself for all or a portion of such expenditures, to the extent permitted by law, with the proceeds of the Agreement or other tax-exempt obligations to be delivered by the City. The maximum principal amount of the Agreement or other tax-exempt obligations expected to be delivered for the Project is not expected to exceed \$1,900,000.

Section 6. This resolution will take effect and be in full force from and after its adoption by the City Council of the City.
